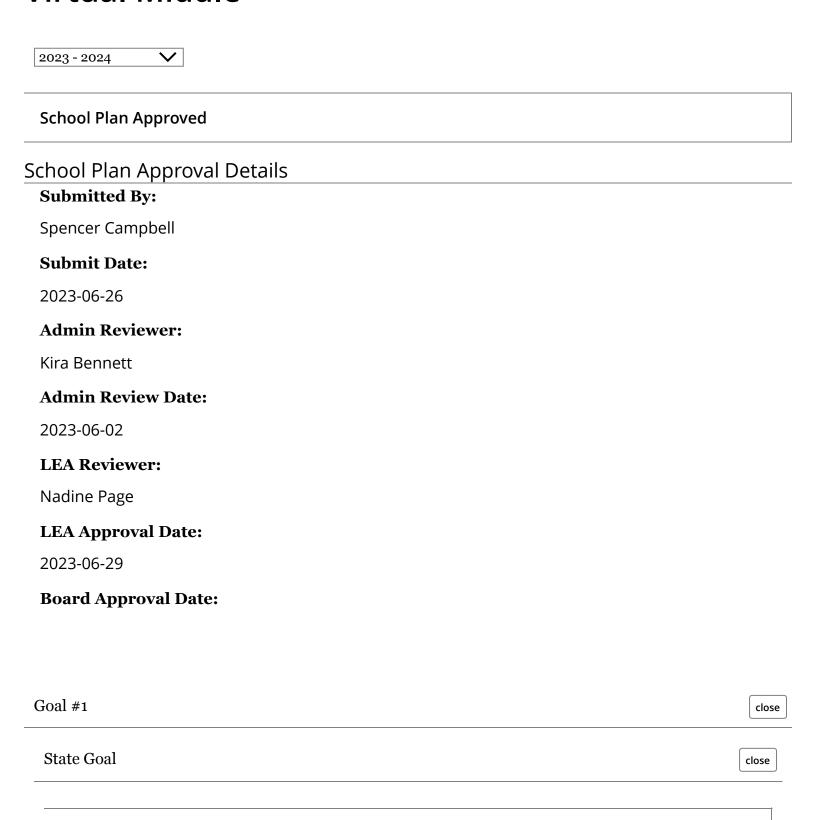
Current School Plan 2023-2024 - Kelsey Peak Virtual Middle

Action Plan Steps and Expenditures

- 1. New Math Curriculum District-Wide We plan to pay additional hours for teachers to build courses and integrate the new curriculum.
- 2. Increase time with Academic Mentor (Basecamp) Teachers
- 3. Use funds specifically for Home Visit stipends and materials as part of our new Home Visit Plan.
- 4. Add a Math and Writing Lab option for students to attend in person or virtually outside school hours.
- 5. Help cover the cost of an engagement aide to connect families to the school and support virtual students wherever they are.
- 6. We use Panorma and Basecamp lessons to help identify, track, teach, and support students navigating middle school. Panorama allows teachers and staff to identify the academic trends of each student and to come up with solutions.
